#### WASTEWATER (Mr. Berenato, Chair):

**Resolution 20-4-108:** Authorizing the award of a contract to Municipal Maintenance Co. for Procurement of Replacement Pumps, Motors, and Ancillary Parts through The North Jersey Wastewater Cooperative Purchasing System. Amount is \$100,000.00.

Explanation: For Pleasantville Pump Station repair parts.

**Resolution 20-4-109:** Authorizing a shared services agreement between the ACUA and the Atlantic City Municipal Utilities Authority for Lab Testing Services. Estimated revenue to the ACUA is \$20,000.

Explanation: The ACUA will continue to provide lab testing services to the ACMUA for the period June 1, 2020 to May 31, 2021.

### **SOLID WASTE** (Mr. Akers, Chair):

**Resolution 20-4-110:** Authorizing a contract with Caesars Entertainment Corp. for recycling collection services at the rate of \$143.00 per pull plus the prevailing per ton tip fee.

Explanation: Renewal of agreement for recycling roll-off collection services at Caesar's Atlantic City properties (Bally's, Caesar's & Harrah's.) The estimated annual revenue is approximately \$4,100.00.

**Resolution 20-4-111:** Authorizing Application to the New Jersey LEAP Grant Program for Reimbursement of Costs Associated With Implementation of Shared Services Agreements. Amount of grant is \$152,594.00.

Explanation: To assist with certain expenses associated with the implementation of the Shared Services Agreement between the ACUA, Cumberland County Improvement Authority and the City of Vineland.

**Resolution 20-4-112:** Authorizing the Atlantic County Utilities Authority to Implement Competitive Contracting for the Purpose of Upgrade, Share Ownership and Operate a Single-Stream Recycling Processing Facility at the Atlantic County Utilities Authority

Explanation: The ACUA will implement competitive contracting for the purpose of procuring a vendor to operate the Recycling Center and process ACUA recycling tonnage.
