WASTEWATER (Mr. Berenato, Chair):

Resolution 19-5-133: Authorizing a shared services agreement between the ACUA and the Atlantic City Municipal Utilities Authority for Lab Testing Services. Estimated revenue to the ACUA is \$20,000.

Explanation: The ACUA will continue to provide lab testing services to the ACMUA for the period June 1, 2019 to May 31, 2021.

Resolution 19-5-134: Authorizing a Shared Services Agreement between Stockton University and the Atlantic County Utilities Authority for Maintenance & Operation of Pumping Stations. Annual revenue for first year is \$45,500.

Explanation: The ACUA will continue to provide maintenance services for the period from July 1, 2019 to June 30, 2021.

Resolution 19-5-135: Authorizing a rider to the Shared Services Agreement between the Atlantic County Utilities Authority and the County of Atlantic for Operation and Maintenance of Atlantic County Nursing Home Pumping Station, The Gerald L. Gormley Justice Facility Grinding Station, and the Lake Lenape Pumping Station. Additional annual revenue is approximately \$6,900.00.

Explanation: ACUA will provide service to new lift station located at Mays Landing

Camp Site.

Resolution 19-5-136: Authorizing award of contract in Bid 2019-SW-10 for Supply of Landfill Gas Piping Supplies to Core & Main LP. Amount is not to exceed \$100,000.00 for contract period June 1, 2019 to May 31, 2020.

Explanation: The proposal amount reflects the Lump Sum Price for comparative pricing

purposes. ACUA-SNJP Co-op.

Resolution 19-5-137: Authorizing a Shared Services Agreement between the Atlantic County Utilities Authority and Stockton University for Roll-Off Container Services.

Explanation: Stockton will pay the Authority \$114.15 per pull plus tip fees for the Galloway Campus, and \$195.98 per pull at the Atlantic City Campus, for the contract period July 1, 2019 to June 30, 2021. Estimated revenue is \$24,000.00 plus associated tip fees.
