#### **PUBLIC COMMENT:**

**Don Purdy (via zoom)** asked for an explanation of Resolution 20-11-296. He also wanted to know if General Counsel reviews the bid advertisements.

Tom Ganard explained that the NJ Trust requires that the project be advertised in two newspapers. The Authority advertised the project on the ACUA website, but inadvertently did not advertise in two newspapers. General Counsel does not review bid advertisements.

#### **RESOLUTION COMMENTS:**

**Resolution 20-11-285**: Authorizing Settlement of New Jersey Department of Environmental Protection Agency Matter, Re: Notice of Violation: Atlantic County Utilities Authority, EPA Docket No. CAA-02-2016-1306. Explanation: Authorizing settlement and payment of penalty assessment in NJDEP/EPA incinerator ash matter. The amount of the penalty is \$105,000.00.

Sal Perillo explained that this culminates 4 ½ years of negotiations. This settlement represents a substantial concession on NJDEP/EPA's part, recognizing that we are doing the best job possible under the circumstances. However, we still have to continue to comply with the restraints of the Order.

**Resolution 20-11-298:** Authorizing a contract amendment to contract with S. Hughes Electric Co., LLC for Pleasantville Pump Station Emergency Generator, Bid 2020-WW-02. Amount of increase is \$45,175.63. Explanation: Due to unforeseen conditions during foundation excavation.

Mrs. Ward abstained from voting.

**Resolution 20-11-323:** Authorizing the award of an Alternate Method Contract to Edmunds GovTech. Cost is \$22,205.00 for the contract term January 1, 2021 to December 31, 2021. Explanation: For Software Maintenance and Hosting Services.
