## **WASTEWATER** (Mr. Berenato, Chair):

**Resolution 22-3-76:** Authorizing a contract amendment to alternate method contract with Chavond-Barry Engineering Corp. for Incinerator Permitting Consulting Services. Amount of decrease is \$95,000.00.

Explanation: To reduce amount of the initial contract award.

**Resolution 22-3-77:** Authorizing a Shared Services Agreement between the ACUA and the Buena Borough MUA for Lab Testing Services. Estimated amount of revenue to the Authority is \$5,105.74.

Explanation: The ACUA will perform lab testing services for the period April 1, 2022 to March 31, 2023.

**Resolution 22-3-78:** Authorizing an agreement between the Atlantic County Utilities Authority and Woodard and Curran for lab testing services. Estimated amount of revenue to the Authority is \$16,178.60.

Explanation: The ACUA will continue to provide lab testing services to Woodard and Curran, who operates, maintains and manages Maple Shade Township's water and wastewater for the contract term April 1, 2022 to March 31, 2023.

**Resolution 22-3-79:** Authorizing execution of a Demo Equipment Trial Agreement between the Atlantic County Utilities Authority and VeloDyne Systems. Cost to the Authority is \$1,500.00 for shipping.

Explanation: Trial for Polymer Feed Unit to support Fournier Rotary Press trial as part of Solids Handling Project.
