WASTEWATER - Mrs. Ward, Chair

Resolution 24-10-225: Authorizing an agreement with MGM Resorts International, LLC, d/b/a Borgata Hotel, Casino & Spa, for Inspection of Grease Recovery Units.

Explanation: Estimated revenue for 24-month term, from January 1, 2025, to December 31, 2026, is \$24,000.00.

Resolution 24-10-226: Authorizing a contract amendment to contract with Kemira Water Solutions, Bid No. 2023-WW-06, Option "C", for the Supply of Ferric Chloride. Amount of decrease is \$77,778.00.

Explanation: To reduce the contract quantities to reflect 2024 usage.

Resolution 24-10-227: Authorizing option to extend contract with Kemira Water Solutions, Bid No. 2023-WW-06, Option "C", for the Supply of Ferric Chloride Solution for a one-year period beginning January 1, 2025, to December 31, 2025. Amount not to exceed \$98,250.00.

Explanation: The Authority is exercising its option to extend this contract for one year. New total not to exceed amount is \$109,872.00.

Resolution 24-10-228: Authorizing a contract amendment to contract with Nichem Co. for Activated Carbon, Bid No. 2022-WW-06. Amount of decrease is \$48,900.00.

Explanation: To reduce contract quantities to reflect actual usage in 2024.

Resolution 24-10-229: Authorizing a contract amendment to contract with Polydyne, Inc. for the Supply of Polymer Flocculants, Bid No. 2023-WW-09, Option "A". Amount of decrease is \$41,000.00.

Explanation: To reduce contract quantities to reflect actual usage in 2024.

Resolution 24-10-230: Authorizing a contract amendment to contract with Spectrasery, Inc. for Hauling and Disposal of Grit Entrained Sludge, Bid No. 2024-WW-04. Amount of decrease is \$126,000.00.

Explanation: To reduce contract quantities to reflect actual usage in 2024.

Resolution 24-10-231: Authorizing the award of a contract to Cascade Engineering Co. for purchase of 96-gallon recycling carts through the Sourcewell Cooperative Purchasing System. Cost is \$566,614.40.

Explanation: In conjunction with Hamilton Township's collections agreement.

Resolution 24-10-232: Authorizing an Agreement between the Atlantic County Utilities Authority and The Recycling Partnership, Inc. for a Recycling Partnership Grant.

Explanation: Estimated value of the grant is \$148,800.00. Grant funds will be allocated for Hamilton Township recycling carts.

Resolution 24-10-233: Authorizing a Rider to the Shared Services Agreement with Hamilton Township for Certain Solid Waste Collection Services.

Explanation: Rider to recycling collection contract with Hamilton Township to facilitate the purchase of recycling carts. The Township shall pay the Authority a monthly rate of \$5,442.57 for the recycling carts, over five years, beginning November 1, 2024.

Resolution 24-10-234: Authorizing a contract amendment to contract with Mazza Recycling Services, LLC, Bid 2024-SW-10, for Supply and Delivery of Additional Clean-Cut Stone. Amount of increase is \$78,260.56. (Aggregate amendment amount exceeds 20% limitation.)

Explanation: Additional funds needed to purchase tire scrub aggregate for the landfill.

Resolution 24-10-235: Authorizing addendum to contract with AC Landfill Energy, LLC, for Lease, Operating, Management, and Power Purchase Agreement.

Explanation: To make necessary changes to the agreement to include Minimum Monitoring Frequency, Non-Routine Maintenance, and a Meeting Schedule.

Resolution 24-10-236: Authorizing payment to AC Landfill Energy, LLC (Marina Energy) in the amount of \$135,298.79, Invoice #013702, for 2023-2024 Landfill Gas Collection and Control System Upgrades.

Explanation: Awarded to lowest responsible bidder.

Resolution 24-10-238: Authorizing a contract amendment to contract with Johnson & Towers, LLC, for Allison Transmissions, Parts and Services, Bid 2023-SW-15. Amount of increase is \$110,000.00.

Explanation: Additional funds needed due to unanticipated costs for parts and services. (Amendment amount exceeds 20%.)

Resolution 24-10-239: Authorizing award of a contract to McNeilus Truck & Manufacturing through the Sourcewell Government Purchasing Alliance for Parts & Services. Amount is \$70,000.00 for the contract term November 16, 2024, to November 15, 2025.

Explanation: To be utilized for parts, service, and replacement tippers for the collections fleet.
